# **UPDATED SUSTAINABLE BOND FRAMEWORK**

Lloyds Banking Group plc has today published its updated Sustainable Bond Framework which can be found on the Investor Relations section of the Group's website alongside the Second Party Opinion provided by Sustainalytics: <u>Unsecured funding - Lloyds Banking Group plc.</u>

The framework sets out the eligibility criteria for both Green and Social assets for inclusion in the respective Eligible Asset Portfolios, focused on five ICMA Themes: Green Buildings, Renewable Energy, Energy Efficiency and Clean Transportation (together the Green Eligible Asset categories) and Affordable Housing (the Social Eligible Asset category).

A series of investor meetings is being organised by Lloyds Bank Corporate Markets plc (LBCM) on behalf of the Group. The investor calls will take place across 7 sessions over the 25th and 26th April 2024 with LBCM coordinating the meetings.
