In May 2024, **2,543** of our customers in your constituency held basic bank accounts to help them access financial services. **1,535** of our customers were receiving Universal Credit – an increase of **15.3%** since May 2023.

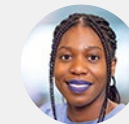
We are committed to helping businesses grow and reach their ambitions.

more homes for social rent to be built within the next ten years.

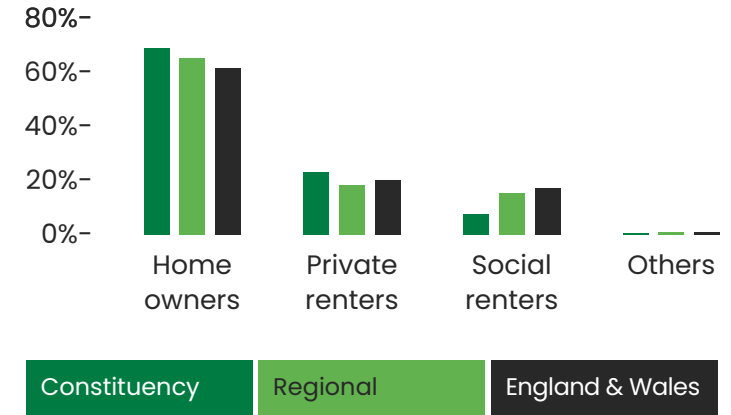
