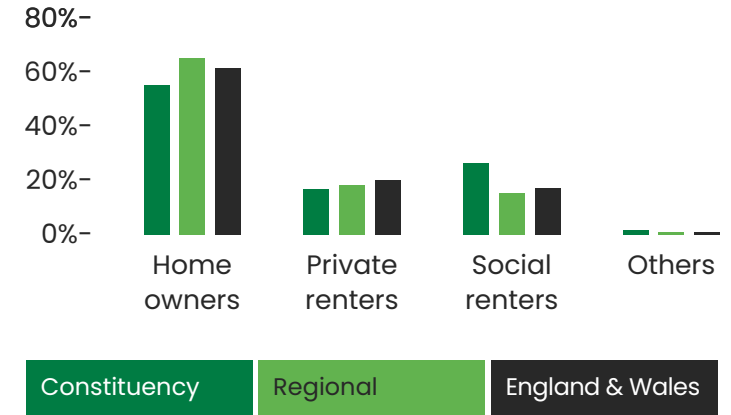


### 26.4%
