In May 2024, **6,804** of our customers in your constituency held basic bank accounts to help them access financial services. **3,884** of our customers were receiving Universal Credit – an increase of **16.0%** since May 2023.

more homes for social rent to be built within the next ten years.

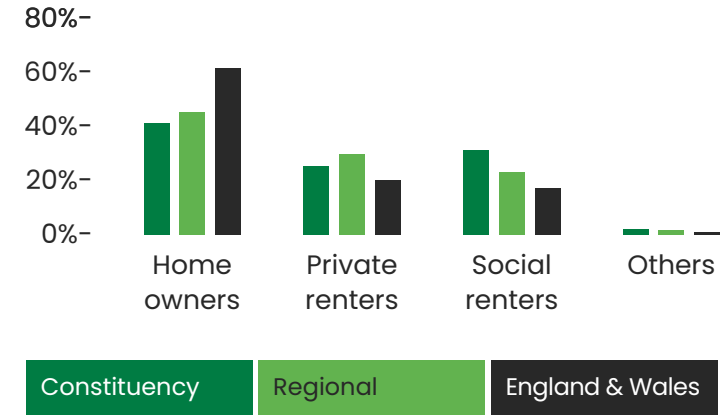


### 31.4%
