 had a balance of **£10,158** in their savings account, an increase of **7.6%** on the previous year

In May 2024, **3,447** of our customers in your constituency held basic bank accounts to help them access financial services. **2,846** of our customers were receiving Universal Credit – an increase of **24.6%** since May 2023.

more homes for social rent to be built within the next ten years.

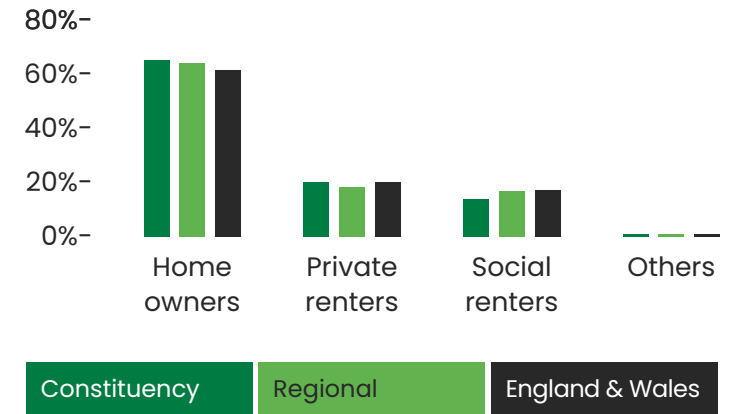


### 13.8%
