 received **£1,490** into their account each month, an increase of **4.5%** on the previous year

 had a balance of **£2,469** in their bank account, a decrease of **11.1%** on the previous year

 had a balance of **£6,356** in their savings account, an increase of **7.5%** on the previous year

In May 2024, **3,691** of our customers in your constituency held basic bank accounts to help them access financial services. **2,887** of our customers were receiving Universal Credit – an increase of **27.1%** since May 2023.

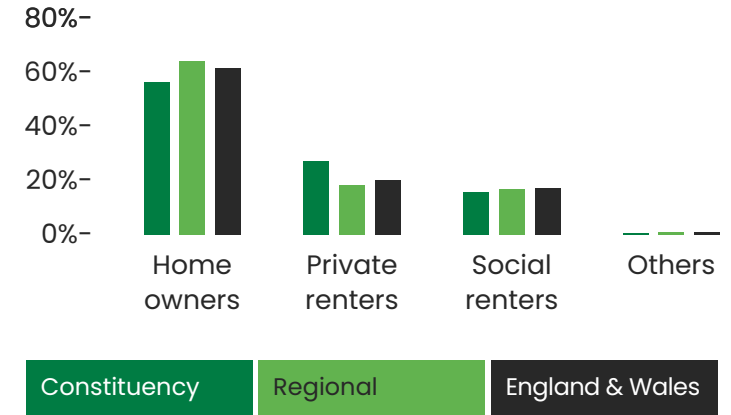
more homes for social rent to be built within the next ten years.
