In May 2024, **1,704** of our customers in your constituency held basic bank accounts to help them access financial services. **1,076** of our customers were receiving Universal Credit – an increase of **19.3%** since May 2023.

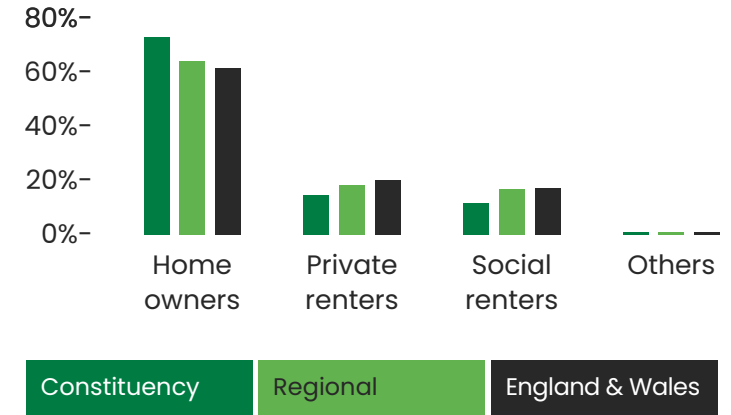
