In May 2024, **2,710** of our customers in your constituency held basic bank accounts to help them access financial services. **1,823** of our customers were receiving Universal Credit - an increase of **15.9%** since May 2023.

more homes for social rent to be built within the next ten years.

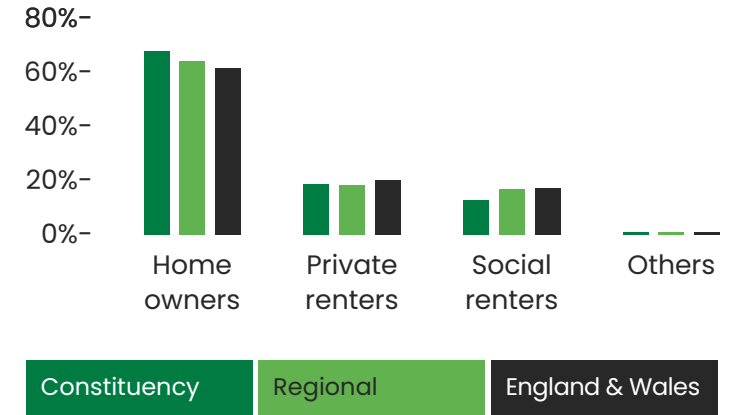


### 12.7%
