Our data from May 2024 shows that, on average, customers in your constituency:

-  received **£2,552** into their account each month, an increase of **9.9%** on the previous year
-  had a balance of **£5,424** in their bank account, a decrease of **6.5%** on the previous year
-  had a balance of **£11,310** in their savings account, an increase of **5.3%** on the previous year

In May 2024, **1,422** of our customers in your constituency held basic bank accounts to help them access financial services. **904** of our customers were receiving Universal Credit – an increase of **23.7%** since May 2023.

more homes for social rent to be built within the next ten years.

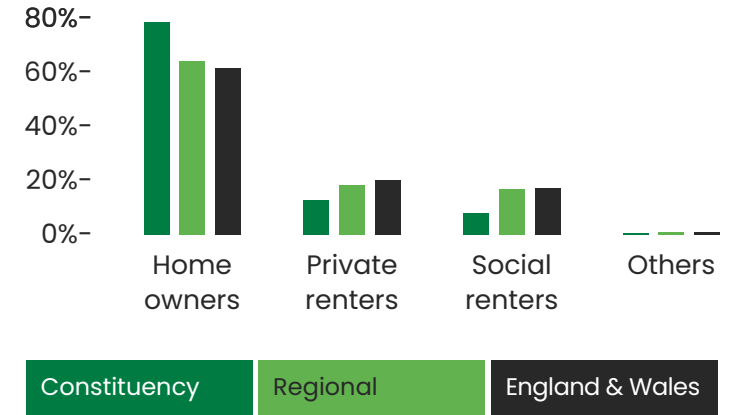


**7.8%**
