more homes for social rent to be built within the next ten years.

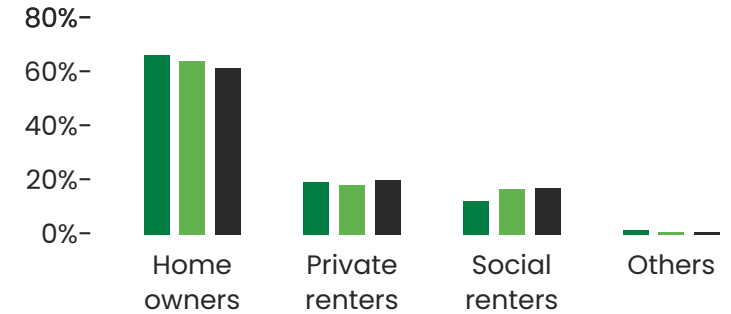
