In May 2024, **2,444** of our customers in your constituency held basic bank accounts to help them access financial services. **1,553** of our customers were receiving Universal Credit - an increase of **19.0%** since May 2023.

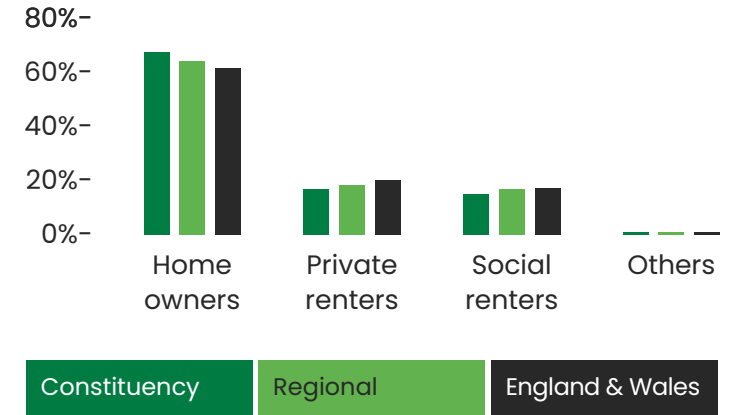
more homes for social rent to be built within the next ten years.
