In May 2024, **1,499** of our customers in your constituency held basic bank accounts to help them access financial services. **922** of our customers were receiving Universal Credit - an increase of **24.3%** since May 2023.

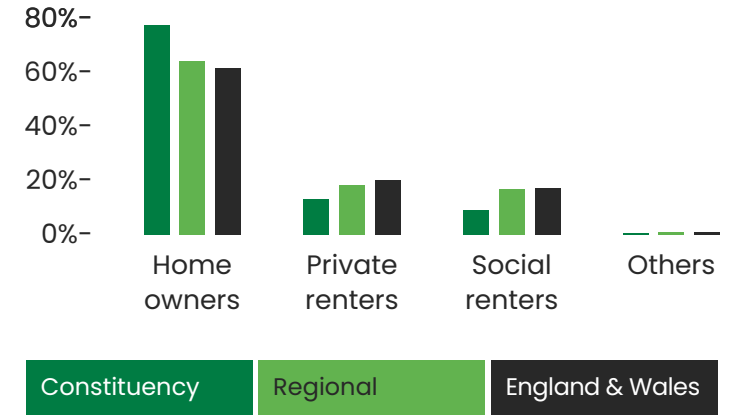
