 received **£1,916** into their account each month, an increase of **6.7%** on the previous year

 had a balance of **£3,598** in their bank account, a decrease of **5.8%** on the previous year

 had a balance of **£8,135** in their savings account, an increase of **4.3%** on the previous year

In May 2024, **3,898** of our customers in your constituency held basic bank accounts to help them access financial services. **4,392** of our customers were receiving Universal Credit – an increase of **15.8%** since May 2023.

more homes for social rent to be built within the next ten years.

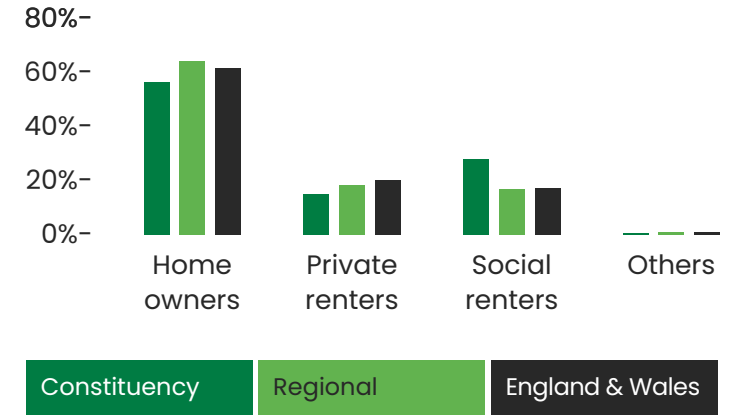


27.8%
