 received **£1,721** into their account each month, an increase of **5.9%** on the previous year

 had a balance of **£3,057** in their bank account, a decrease of **3.7%** on the previous year

 had a balance of **£6,844** in their savings account, an increase of **7.4%** on the previous year

In May 2024, **5,818** of our customers in your constituency held basic bank accounts to help them access financial services. **4,359** of our customers were receiving Universal Credit - an increase of **12.2%** since May 2023.

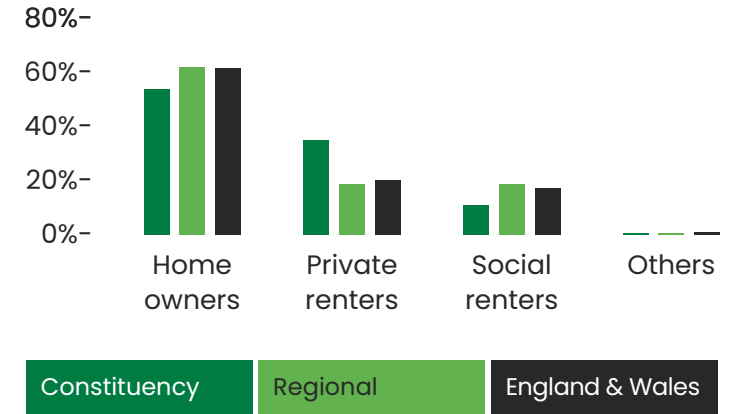
