In May 2024, **4,223** of our customers in your constituency held basic bank accounts to help them access financial services. **3,683** of our customers were receiving Universal Credit - an increase of **16.4%** since May 2023.

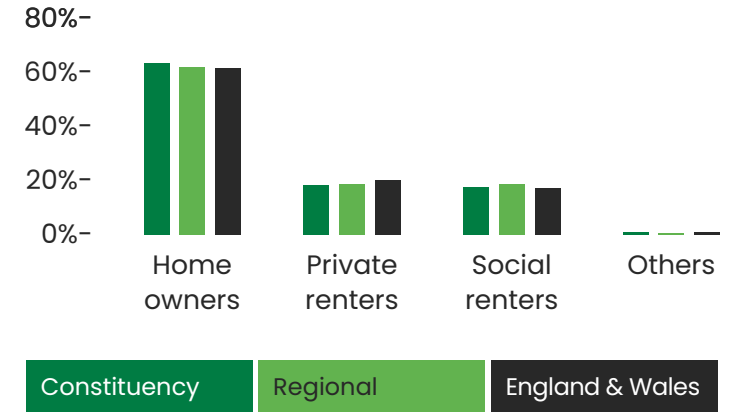


17.5%
