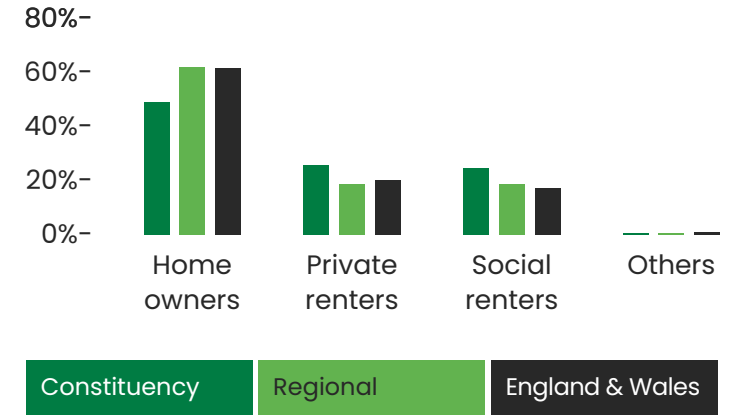


24.7%
