 had a balance of **£4,790** in their savings account, an increase of **7.0%** on the previous year

In May 2024, **4,811** of our customers in your constituency held basic bank accounts to help them access financial services. **4,486** of our customers were receiving Universal Credit - an increase of **18.5%** since May 2023.

more homes for social rent to be built within the next ten years.

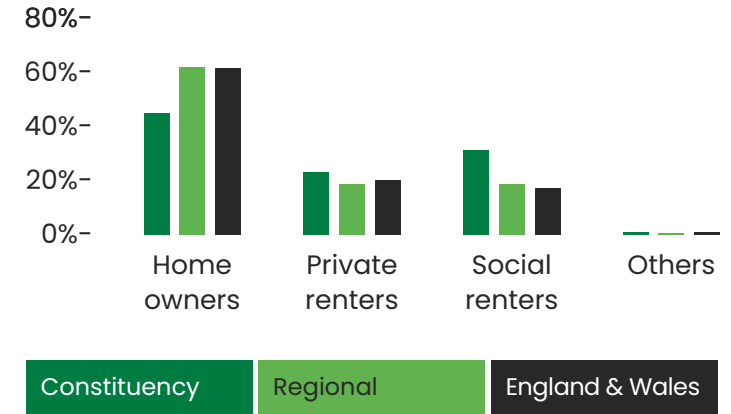


31.3%
