had a balance of £3,459 in their bank account, a decrease of 6.8% on the previous year



had a balance of £7,349 in their savings account, an increase of 5.0% on the previous year

In May 2024, 2,728 of our customers in your constituency held basic bank accounts to help them access financial services. 2.612 of our customers were receiving Universal Credit - an increase of **34.8%** since May 2023.


