Our data from May 2024 shows that, on average, customers in your constituency:

 received **£2,471** into their account each month, an increase of **13.4%** on the previous year

 had a balance of **£4,842** in their bank account, a decrease of **9.8%** on the previous year

 had a balance of **£10,426** in their savings account, an increase of **5.1%** on the previous year

In May 2024, **1,633** of our customers in your constituency held basic bank accounts to help them access financial services. **1,159** of our customers were receiving Universal Credit – an increase of **15.8%** since May 2023.

Around 1.5m households are on social housing waiting lists and record numbers of households are trapped in temporary accommodation. The chronic shortage of social homes is placing increased pressure on other parts of the housing market.

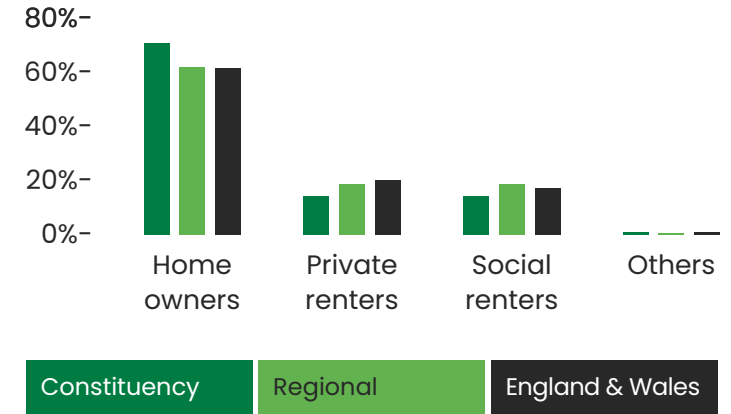
