 had a balance of **£10,854** in their savings account, an increase of **8.6%** on the previous year

In May 2024, **2,696** of our customers in your constituency held basic bank accounts to help them access financial services. **1,503** of our customers were receiving Universal Credit - an increase of **19.9%** since May 2023.

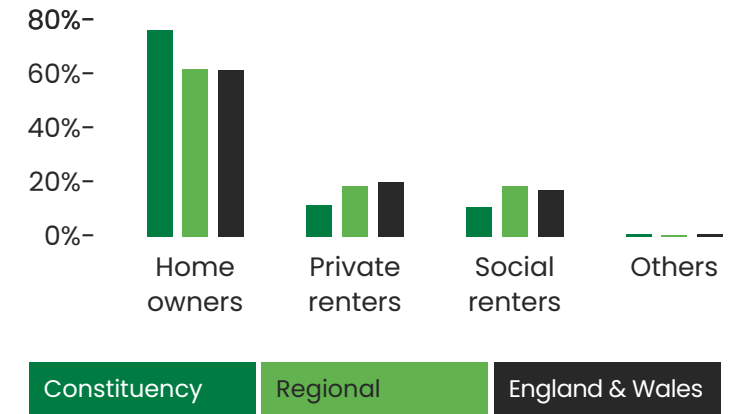
