-  received **£1,943** into their account each month, an increase of **7.6%** on the previous year
-  had a balance of **£3,779** in their bank account, a decrease of **9.3%** on the previous year
-  had a balance of **£9,339** in their savings account, an increase of **7.0%** on the previous year

In May 2024, **3,761** of our customers in your constituency held basic bank accounts to help them access financial services. **2,521** of our customers were receiving Universal Credit – an increase of **17.9%** since May 2023.

more homes for social rent to be built within the next ten years.

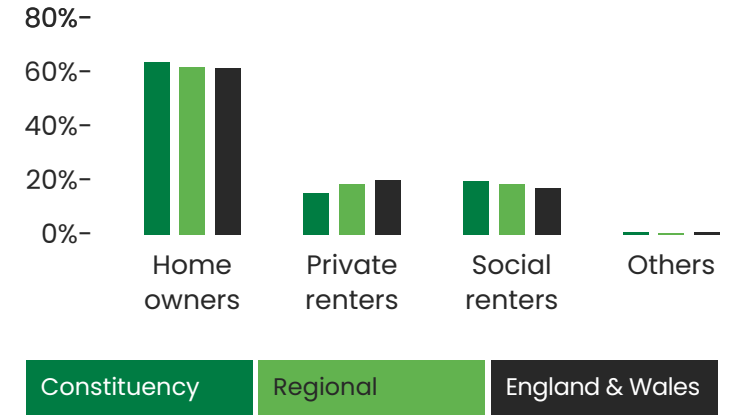


### 19.8%
