had a balance of £5,133 in their bank account, a decrease of 13.7% on the previous year



had a balance of £11,921 in their savings account, the same as the previous year

In May 2024, 1,811 of our customers in your constituency held basic bank accounts to help them access financial services. 1.367 of our customers were receiving Universal Credit - an increase of 17.6% since May 2023.




