 had a balance of **£15,471** in their savings account, an increase of **6.0%** on the previous year

In May 2024, **1,512** of our customers in your constituency held basic bank accounts to help them access financial services. **798** of our customers were receiving Universal Credit - an increase of **16.3%** since May 2023.

more homes for social rent to be built within the next ten years.

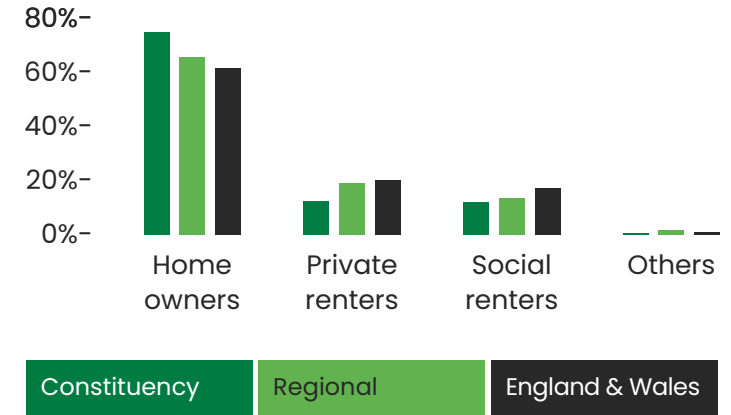
