In May 2024, **2,259** of our customers in your constituency held basic bank accounts to help them access financial services. **1,868** of our customers were receiving Universal Credit – an increase of **15.4%** since May 2023.

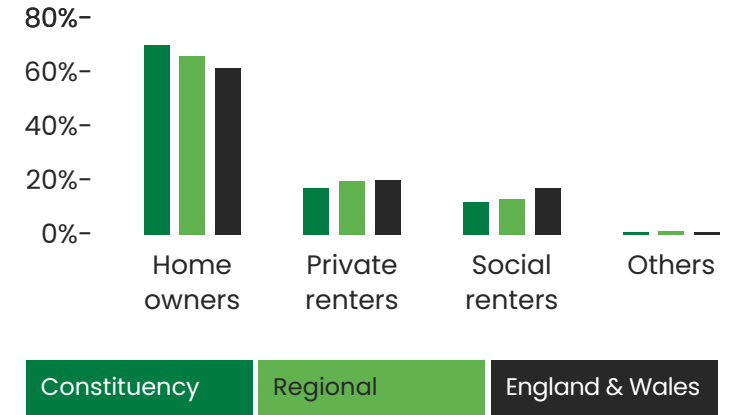
