had a balance of £8,871 in their savings account, an increase of 6.7% on the previous year

In May 2024, 3,314 of our customers in your constituency held basic bank accounts to help them access financial services. 2.515 of our customers were receiving Universal Credit - an increase of 20.9% since May 2023.


