Our data from May 2024 shows that, on average, customers in your constituency:

-  received **£1,894** into their account each month, an increase of **8.2%** on the previous year
-  had a balance of **£3,177** in their bank account, a decrease of **2.5%** on the previous year
-  had a balance of **£6,817** in their savings account, an increase of **4.5%** on the previous year

In May 2024, **5,585** of our customers in your constituency held basic bank accounts to help them access financial services. **5,341** of our customers were receiving Universal Credit – an increase of **19.7%** since May 2023.

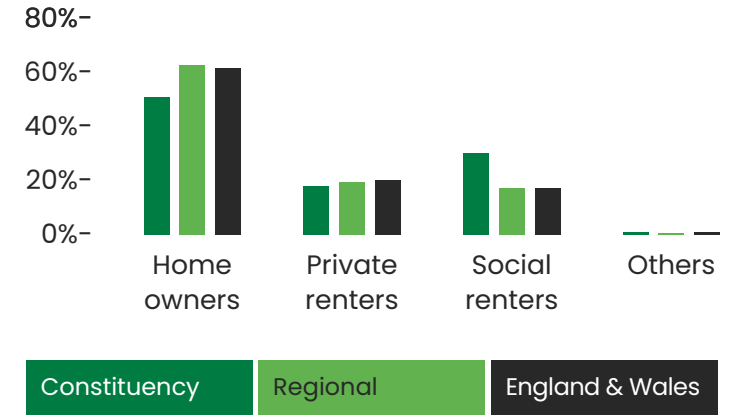


30.3%
