-  had a balance of **£4,356** in their bank account, a decrease of **7.3%** on the previous year
-  had a balance of **£9,820** in their savings account, an increase of **7.1%** on the previous year

In May 2024, **3,881** of our customers in your constituency held basic bank accounts to help them access financial services. **2,128** of our customers were receiving Universal Credit – an increase of **18.1%** since May 2023.

more homes for social rent to be built within the next ten years.

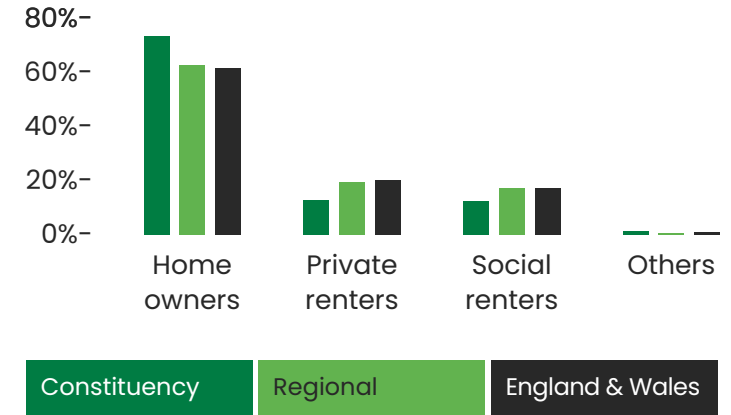
